Sealed quotation or electronic sealed quotation must be submitted to the Godawari Municipality, Office of the Godawari Municipal Executive, Bajrabarahi, Lalitpur by hand/courier or Interested bidders should submit online bids through e-procurement portal <http://www.bolpatra.gov.np/egp> only on or before 12:00 hrs on 2074/10/15BS (2018/01/29 AD). Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2074 issued by PPMO which are available in e-GP system. Bids received after this deadline will be rejected.
6. The sealed quotation will be opened in the presence of Bidders' representatives who choose to attend at 13:00 on 2074/10/15 BS (2018/01/29 AD). at the office specified above. Bids must be valid for a period of **45 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **as specified in table below**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
